The Government vide G.O.Ms.No.15, Higher Education (UE.II) Department, Dated.29.06.2019 issued orders implementing UGC Pay Scales, 2016 to the University and College Teachers of all the Universities in the State including Professor Jayashankar Telangana Agricultural University in line with the UGC Guidelines 2018 (Ref.1<sup>st</sup>). Accordingly, the University implemented the PJTAU Teachers (CAS) Regulations 2019 for the Teachers eligible for promotion under CAS vide ref.2<sup>nd</sup> cited. Further the University has made certain amendments time to time as per the University requirement and also amendments made by UGC from time to time vide references 3<sup>rd</sup> to 6<sup>th</sup> cited.

The Career Advancement Scheme is a package under UGC guidelines 2018, which provides promotions to the Teachers / Scientists in the University, provided they fulfill the conditions prescribed under the PJTAU Teachers (CAS) Regulations 2021 (Ref.3<sup>rd</sup>).

The candidates who are eligible up to 31.12.2024 will be assessed as per PJTAU Teachers (CAS) Regulations, 2011, unless the candidate specifically mention for evaluation under PJTAU Teachers (CAS) Regulations, 2021. However, the candidates who are eligible w.e.f. 01.01.2025 to 30.06.2025 shall be assessed only PJTAU Teachers (CAS) Regulations, 2021 only.

The Teachers / Scientists who are eligible for placement in Assistant Professor (Senior Scale) ie., Academic level-11, Assistant Professor (Selection Grade) ie., Academic level - 12, Associate Professor ie., Academic level -13A, Professor Academic level -14 and Professor (Academic level -15) as on 30-06-2025 for 28<sup>th</sup> batch are requested to send their filled in application forms in the prescribed format (5 sets) along with Self-Assessment Reports in Part III and Part IV for the assessment period through proper channel, as per eligibility criteria under PJTAU Teacher (CAS) Regulations 2021. The last date for receipt of application forms is on or before **16-10-2025** at respective Associate Deans / ADRs / Director, for verification and certification of the concerned Internal Quality Assessment Cell and the same should reach the Registrar, PJTAU on or before **22-10-2025 by 4.30 P.M.**

All the Associate Deans of Colleges, Associate Directors of Research of Zones, Directors of Units, and Heads of Research Stations / Centres /KVKs/TRVKs /Polytechnics are requested to bring the same to the notice of all the Teachers / Scientists working under their control. They are also requested to verify carefully the service particulars and details of leave availed, by the candidates by verifying the same with their Service Registers and **certify the correctness of the particulars furnished in the application in the prescribed proforma with their endorsement.**

The applicants are requested to furnish the copies of qualifications and last date of **viva-voce exam held**, which is essential to consider Ph.D qualification.

In the column 14 of application related to leave particulars it should not be indicated as "Not applicable" or left blank. It has to be indicated clearly whether any leave i.e. EOL (without pay & allowances) is availed, if not "Nil" has to be indicated.


