**Note:** The seats if any arise even on the day of the counselling will also be considered and filled up along with the seats as notified above.

**Eligibility:**

- A pass in two year Intermediate Examination conducted by the Board of Intermediate Education or any other examination recognized as equivalent thereto by the University or Intermediate Board with the following subjects namely:
  - Physical Sciences
  - Mathematics
- The candidates for admission to these courses shall be required to have completed **17** years of age with an upper age limit of **22** years for all the candidates, **25** years in respect of SC and ST candidates and **27** years for Physically Handicapped candidates **as on 31<sup>st</sup> December** of the year of admission.

**Criteria for selection (Priority):**

**Priority 1:** The seats shall be filled-up **based on the ranks obtained by the candidates under Engineering Stream** in the **TG EAPCET-2026**.

**Priority 2:** The vacant unfilled seats if any, shall be filled-up **based on the marks obtained in Intermediate/Class 10+2 or its equivalent examination with not less than 50% marks in the prescribed group subjects** by the candidates without TG EAPCET-2026 ranks.

➤ In case of tie, the age of the candidates shall be taken into consideration and the older candidates shall be given preference for the seat.

**Reservation of Seats:**

- The rule of reservation (OC:46%, EWS;10%, BC-A:7%, BC-B;10%, BC-C:1%, BC-D:7%, BC-E:4%, SC-Group-I : 1%, SC-Group-II : 9%, SC-Group-III: 5%, ST:10%) will be followed as per the guidelines issued by the Government of Telangana from time to time).
- The rule of reservation will be followed as per the guidelines issued by the Government of Telangana from time to time.**

❖ **Reservation of seats under Farmer's/Agriculture Labourers'/Rural quota**

*The seats for the candidates coming from the families of Agriculturalists (Farmers' Quota) and Agriculture Labourers' (Agriculture Labourers' Quota) have been reserved in various UG courses being offered by PJTAU. The details on the reservation percentage of the seats under Farmer's, Agriculture Labourers' and Rural quotas in UG courses are given below.*

**Note:**

- **ANNEXURE-I:** It is a proforma to be certified by the Head of the Institution(s) with his office seal that the candidate has studied for a minimum period of four years in schools located in Non-Municipal areas (**Non-Municipal Area Certificate**).
- **ANNEXURE-II:** It is a proforma indicating the patta numbers and extent of land owned by the **candidate/parent(s)**, duly certified by the Tahsildar with his office seal (or) attested photocopies of Pattadar Pass Book as evidence of the extent of agricultural land.

- **ANNEXURE-III:** It is a proforma indicating the Job card (EGS card) number of the candidate/parent(s) and certifying that the candidate/parents/grandparents **do not own any Agricultural Land**, duly certified by the Tahsildar with his office seal.
- **ANNEXURE-I/ANNEXURE-II/ANNEXURE-III** need to be filled in with the signatures of concerned officials viz., Head of respective Institution(s) and Tahsildar, respectively, along with the office seal. Otherwise, the claim of the candidates under respective categories will be summarily rejected.

#### ❖ **Reservation of seats for Women:**

- In each course, 33  $\frac{1}{3}$  % of the seats shall be horizontally reserved in favour of women candidates from each category.

#### Allocation of seats:

- Of the total seats, 85% of the seats are reserved for local candidates, and 15% of seats are unreserved.

**In this regard, as per the G.O. Ms. No. 15 of the Higher Education (TE) Department, Dated: 27-02-2025, the reservation of seats is as follows:**

Admission to 85% of the seats shall be reserved in each course in the Educational Institutions in the State for local candidates of OU area as specified in the Andhra Pradesh Educational Institutions (Regulations and Admissions) Order, 1974 as subsequently amended and the remaining 15% of the seats shall be un-reserved seats to the following:

- a. All the candidates are eligible to be declared as local candidates of the O.U. area.
- b. Candidates who have resided in the State for a total period of ten years, excluding periods of study outside the State, or either of whose parents has resided in the State for a total period of ten years, excluding periods of employment outside the State;
- c. Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, Universities, and other similar quasi-public institutions within the State; and
- d. Candidates who are spouses of those in the employment of the State or Central Government, Public Sector Corporations, Local Bodies, Universities and educational institutions recognized by the Government or a University or other competent authority, and similar other quasi-Government institutions within the State.

**Note:** The guidelines issued by the Government of Telangana from time to time shall be followed scrupulously, including the reservations for 15% of seats under the un-reserved quota.

#### Hostel facility:

- Hostel facility shall be provided, subject to the availability of accommodation in the respective colleges.

#### Original certificates to be produced at the time of counselling:

- SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
- Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).
- Telangana EAPCET-2025 Rank Card of Engineering Stream.
- Bonafide / Study Certificate from 4<sup>th</sup> to 12<sup>th</sup> Class.
- Transfer Certificate of the institute last studied.
- Residence Certificate of Telangana.
- The certified copy of the Social Status Certificate issued by the competent authority of Telangana in case of applicants belonging to Backward Classes, Scheduled Castes, and Scheduled Tribes.
- The latest certified copy of the **EWS Certificate valid for the year 2025-26** issued by the competent authority in case of applicants belonging to the EWS category.
- Non-Municipal Area Study Certificate (ANNEXURE-I), if applicable.
- Agricultural Land Holding Certificate (ANNEXURE-II), if applicable.
- Legal heir certificate, if applicable.
- Certificate claiming Agriculture Labourers' quota (ANNEXURE-III), if applicable.
- The certified copy of the Physically Challenged Certificate, if applicable.
- Children of Armed Personnel Certificate/Defence Personnel Certificate, if applicable.
- National Cadet Corps (NCC) Certificate, if applicable.
- Sports and Games Certificates along with Form I, II, III & IV (whichever is applicable), which are mandatory for claiming a seat under the Sports quota, if applicable.

- \* The Lab/Library/Hostel/Mess deposits are refundable. The mess and hostel charges are additional.

**Note:**

- The candidate who secures a seat (Regular/Special quota) *shall submit the certificates in Original along with the prescribed fees (in cash)* at the time of counselling itself.
- The rules and regulations with regard to eligibility, age, reservations, etc., are the same for the Special quota that apply to the candidates admitted under the regular quota.
- The candidates selected under the Special quota shall be treated on par with regular quota students. No special amenities or facilities shall be provided.
- The unfilled seats under the special quota shall not be filled from any other stream and shall be kept vacant.
- The candidates admitted under the special quota are not eligible for any reimbursement of fees or educational concessions offered by the Government.*

**Important Instructions:**

- This notification shall be treated as individual intimation. No separate intimation will be sent.
- Open Competition includes all categories viz., OC, EWS, BC, SC-I, SC-II, SC-III & ST (by merit only).
- The candidates are required to produce all the relevant original certificates at the time of counselling failing which the candidature for admission will be disqualified.
- If the admitted candidate cancels his/her seat before closure of the admission process, the entire fee collected from the student shall be refunded in full after deducting Rs. 2,000/- (@ Rs. 10,000/- for Special quota) as processing fee.*
- Any cancellation/withdrawal of admissions after the closure of the admission process, the candidate shall forfeit the entire fees (except the caution deposits). In addition, the candidate has to pay Rs. 2,000/- (@ Rs. 10,000/- for Special quota) as processing fee.*
- Selection of candidates under BC, EWS, SC-I, SC-II, SC-III & ST quota is subject to clearance by the respective social status by the respective Directorates of Government of Telangana.
- The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.
- Candidates called for counselling shall have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate during counselling.
- The University doesn't guarantee any employment to the candidates joining the course.

- Candidates are required to read the prospectus thoroughly before attending the counselling.
- More number of candidates than availability of seats are called for Counselling and hence mere attendance / participation during counselling does not guarantee admission.
- Candidates should report at the Counselling center one hour before the scheduled time.
- Candidates belonging to BC, EWS, SC-I, SC-II, SC-III & ST Categories should bring two sets of Xerox copies of their caste certificate to be submitted at the counselling center.
- **The candidates selected for admission should submit medical fitness certificate at the time of reporting in the college.**
- **The selected candidates who have not submitted the online application shall pay an amount of Rs.3000/- (Rs.1500/- in respect of SC/ST/PH candidates) towards the registration fee immediately.**
