Sub:- PJTAU – Admission into various Under Graduate Courses of PJTAU under NRI / NRI Sponsored quota / Indian Nationals for the academic year 2026-27 – Certificate verification and Walk-in Counselling - Intimation - Regarding.

With reference to the subject cited, it is to inform that the certificate verification and Walk-in Counselling of all the applicants / non-applicants under NRI / NRI sponsored quota / Indian Nationals for admission into various Under Graduate Courses of PJTAU for the academic year 2026-27, is scheduled **on 23-09-2026 at 10:00 AM at the Examinations Centre, PJTAU, Rajendranagar, Hyderabad.**

Note: The leftover seats under the NRI / NRI Sponsored quota shall be filled with Indian Nationals.

Hence, all the applicants / non-applicants who seeks admission into various Under Graduate Courses of PJTAU under NRI/NRI sponsored quota / Indian Nationals for the AY 2026-27 are informed to bring the following original certificates along with two sets of Xerox copies and two passport size photographs on said date for verification.

(For both NRI/NRI sponsored quota & Indian Nationals):

1. Birth Certificate/Proof of Date of Birth (SSC Certificate)
2. Higher Secondary (10+2) or Equivalent Examination Mark Sheet.
3. Transfer Certificate/Migration Certificate issued by the Head of the Institute/University last attended (whichever is applicable).
4. Bonafide / Study Certificate issued by the Head of Institution last attended.
5. Medical Fitness Certificate.

(For NRI / NRI Sponsored quota candidates only):

6. An undertaking by the candidate and parent on stamp paper (Rs.100/- or equivalent currency) notarized (**ANNEXURE-A**).
7. An undertaking by the Sponsor on stamp paper (Rs.100/- or equivalent currency) notarized (**ANNEXURE-B**).
8. Self-certification documents of the sponsor showing the proof of NRI status.
9. Work Permit or Business Establishment, as applicable.
10. Valid Passport and Visa of the Financial Sponsor.
11. Bank statement of the sponsorer showing the latest transaction of the previous 6 months.

After verification of certificates, provisional admission shall be given to the candidates who are found eligible for admission into various Under Graduate Courses of PJTAU under NRI / NRI sponsored quota / Indian Nationals for the AY 2026-27. The Provisionally selected candidates shall pay the following fee immediately at the allotted Colleges i.e. on 23.09.2026 itself.

- A.** Rs. 10,80,000/-(Rupees Ten Lakhs Eighty Thousand only) as Institutional Economic Fee for the entire course (@ Rs.1,35,000/- per semester) for candidates admitted under the NRI / NRI Sponsored quota. All other Regular fees (UF & NUF), Hostel & Mess charges and others if any are additional.
- B.** If the left over seats under NRI / NRI sponsored quota are filled up with Indian Nationals, the Institutional Economic fee shall be paid in Indian Rupees equivalent to Rs.1,35,000/- per semester for eight semesters (Regular fees (UF+NUF), Hostel & Mess charges and others if any are additional).
